

# Commercial Lighting Incentive Program



## Description

LADWP's Commercial Lighting Incentive Program (CLIP) provides rebates on the installation of newly purchased and installed energy-efficient lighting and controls. CLIP's calculated savings approach allows you to tailor your lighting efficiency upgrades to better meet your lighting needs, attain greater energy savings, and receive higher incentives.

## Incentive Levels

Incentives are based on the calculated energy savings of each project, with rates ranging from \$0.08-\$0.24 per kilowatt-hour (kWh) of annualized savings. Incentives now cover up to 100% of the project cost.

Incentive Categories	Incentive Levels as of July 1, 2016
Lighting Fixture Replacement or Retrofit Tier 1 Tier 2	\$0.08/kWh \$0.24/kWh
Sensor-Based Controls	\$0.15/kWh
Lamp-Only Retrofits, Interactive Effects, Other	\$0.08/kWh

## Energy Saving Lighting Measures

- LED Interior Ceiling Mounted, Downlight and Highbay Fixtures
- Exterior LED Pole Mounted and Wallpack Fixtures
- LED Screw-In Lamps

- Tubular LED "Plug-and-Play" Lamps
- Occupancy Sensors and Daylight Controls
- New Induction Lamps and Fixtures
- High Performance Reduced Wattage Fluorescent Lamps and Ballasts

## Requirements

- LADWP business electric customers, in good standing, whose average monthly electrical use is greater than 200 kW.
- Qualifying equipment must have received LADWP approval prior to purchase, installation and operation
- Rebates will be reserved on a first-come, first-served basis until funds are exhausted
- The project must achieve a minimum of 10% energy savings
- Projects not completed within 120 days of LADWP pre-approval may be cancelled, and reserved rebates returned to the program fund

- Submit all required documentation required in application
- Wait to receive LADWP approval before starting your project
- Notify LADWP when the installation is complete
- Upon final approval, LADWP will mail a rebate check
