# City Trunk Line South Unit 3

#### **Project Description**

As part of LADWP's Capital Improvement Program the City Trunk Line South Unit 3 Project will replace a 102-year



Tentative Project Schedule July 2016 – October 2022 Region North Hollywood old water pipeline in North Hollywood that runs along Whitsett Ave. from Vanowen St. to Magnolia Blvd.

Open trench and pipe jacking construction will be used to install 10,250 linear feet of 60inch diameter welded steel pipeline. Once complete the CTLS 3 Project will comprise approximately 25% of the City Trunk Line South system that will connect the Los Angeles Aqueduct Filtration Plant to the Franklin Reservoir.

#### Construction Information

The project is divided into two phases with 14 work areas. Construction will rotate among the work areas to minimize traffic impacts along Whitsett Avenue.

Phase I construction began in July 2016 and was completed in June 2020.

Phase II began in August 2019 and is tentatively scheduled to be completed by October 2022. Hours of work will be 7:00 a.m. to 6:00 p.m. Monday through Friday with some Saturday work from 8:00 a.m. to 5:00 p.m. Overnight work may be required as needed for underground construction from 6:00 p.m. to 7:00 a.m.

A minimum of one lane will be open to northbound and southbound traffic in most active work areas except Work Area 14, which will be limited to one southbound lane.

Temporary tow-away/no parking signs will be posted as needed. Driveway and local access will be provided.
