## **BARREN RIDGE RENEWABLE TRANSMISSION PROJECT**






LADWP is proposing the Barren Ridge Renewable Transmission Project (BRRTP) to access clean, renewable resources in the Tehachapi Mountain and Mojave Desert areas, and to improve reliability and upgrade transmission capacity. The Project is located in Kern and Los Angeles counties, and is approximately 75 miles in length extending from the Barren Ridge Switching Station to Rinaldi Substation, and approximately 17 miles from the Castaic Power Plant to the proposed Haskell Switching Station. The Project proposes the following:

- Construction of approximately 60 miles of a 230 kilovolt (kV) double-circuit transmission line from the LADWP Barren Ridge Switching Station to Haskell Canyon;
- Addition of approximately 12 miles of a 230 kV circuit on the existing double-circuit structures from Haskell Canyon to the Castaic Power Plant;
- 3. Upgrade of approximately 75 miles of the existing Owens Gorge-Rinaldi 230 kV transmission line with larger capacity conductors from the Barren Ridge Switching Station to the Rinaldi Substation;
- 4. Construction of a new electrical switching station in Haskell Canyon.

LADWP, the Forest Service, and BLM are preparing a joint Environmental Impact Statement (EIS) and Environmental Impact Report (EIR) for the proposed BRRTP. As part of the BRRPT's public outreach program, five
