APPLICATION PROCEDURES

Visit www.ladwp.com/ladwpzbd to download all of the application documents and to review the Terms and Conditions and participation requirements to determine if you qualify.

All projects require LADWP approval prior to the installation of any equipment. You must submit an application package to reserve funds.

The LADWP Zero By Design application package includes:

- Fully completed and signed LADWP Zero By Design application (Part A), LADWP ZBD supplemental form (Part C) and Authorization Form (if applicable).
- Completed LADWP ZBD Workbook (Excel document available for download at www.ladwp.com/ladwpzbd).
- If also applying for the Design Team incentive, completed and signed Design Team application (Part D), along with your energy model and, if applicable, any other energy savings calculations.
- Project plans, schedules and blueprints (Please refer to the Project Drawing Set and Materials Information checklist).
- Completed and signed IRS Form W-9 for the legal entity that will receive the incentive payment.
- Schematic drawings and/or manufacturer specification sheets for all proposed equipment, if applicable.

A LADWP ZBD representative will contact you to confirm receipt of the application.

Projects not completed within 48 months of LADWP approval may be cancelled and reserved funds returned to the program fund.

Once the project is completed, you must submit:

- Invoices and/or documentation to support installation costs.
- Completed and signed LADWP ZBD Installation Report.
- LADWP ZBD Payment Assignment Form (if applicable).
- Revised energy model per as built.
- Certificate of Occupancy.
- LADWP electric account number.

After all required documents are received, you will be contacted to schedule a post-construction verification.

After installation is verified, a LADWP ZBD representative will review all documentation and process the incentive payment.
